New Business

- · Quilt Beginnings Quilt Beginnings has a number of quilt "kits" for assembly for Haven House/Stitchin Sisters. With Beth Starkey-Hill unable to pick them up, Julie Pietsmeyer volunteered to do this! Thank-you, Julie!
- The contract with Ohio Christian University for next year's Quilt Show is happily only \$224 over this year's cost; the contract is yet to be signed. Judy expressed a concern with OCU over internet service; this year, service was sketchy on the back wall. Notes from this year's post-show retrospective have been placed on all the tables. Please take a moment and read those. Notable items:
 - Red, White and Blue Quilts will be used as "filler" quilts in next year's quilt display. These quilts will come from Guild members, and do not necessarily have to have received "Best of Show" status or have been judged.
 - A suggestion was made to have general information about the Guild (location, meeting time, dues, etc.,) available to Show attendees; next year, Val Hoffman will make a poster that could be photographed that contains this information.
 - A Quilt of Valor was made collectively from blocks pieced at this year's Spring Retreat; this will be given to a veteran either in the Guild or "familied" through the Guild. This Quilt could be registered with the official Quilt of Valor web site and presented locally through us. It would be great publicity for the Guild.
 - A suggestion was made to update the quilt categories for judging next year. Many of the current categories are a bit stale to our current times. For example, many fabric panels are designed to be cut apart and pieced into a quilt or wall hanging; our current judging rules do not allow for this. Judy suggested that next year, a committee be organized to review this information.
 - Val Hoffman brought the suggestion forward from the Retrospective to discontinue the hourly door prizes from the Quilt Show. Many do not pick up their item or are disappointed by what they receive. A motion was made by Cherie Del Ponte to discontinue this feature of the Show; Margaret Parker seconded the motion. All were in favor; this motion carried.
- **Membership!** Next month, our membership drive begins! Dues are \$35/year, and need to be paid by the December meeting! Cathie Turner shared that new directories will come out next year, and if your dues are not paid by December 15, you won't make the directory! (Suggestion: paying buy cash in an envelope with your name on it is kindest to our Treasurer!)

Old Business

- **2026 Officers** Next year, the following offices will need to be filled for the Guild, as the current Officers are expiring from their terms. Please be thinking about volunteering to serve in a position:
 - President Responsibilities include running the monthly meetings, obtaining and supporting the contract with Ohio Christian University for the Quilt Show, then largely overseeing the Quilt Show, etc.

- Vice President Acts as support for the President during the monthly meetings as needed (i.e., possibly making coffee, setting up the sound equipment), also overseeing the Quilt Show, etc.
- Secretary Taking and disseminating the monthly meeting minutes, recording any changes to the Constitution or By-laws, supporting the President/Vice President as necessary.
- Treasurer Overseeing all financial information to include money movement in/out of the Guild's account, onsite daily at the Quilt Show recording money taken in, paying out money as appropriate, supporting the Membership via the taking in of dues, etc.
- Judy Clifton "asked" Sherri Berry (aided by Cindy Horsky) to be a nominating committee to seek candidates to fill these needed positions. Sherri agreed!
- Adult Protective Services Judy Clifton shared that 18 of the needed 27 have been collected for Adult Protective Services; these will be distributed at Christmas. Size of the piece should be approximately 50" x 60".
- Christmas Lunch Mardee Stover shared that this year's Christmas Lunch would be catered by Chef's Danyelle Tucker and Cody Rutherford from R Kitchen (Chillicothe). The lunch will be hosted in our December 4 meeting. Please sign-up so that she can give an accurate participant count to the caterer.
- Next Year's Sales Room Mardee also shared that she doesn't need any more bags for the Sales Room! She is fine for 2026!

A motion was made to adjourn the meeting by Betty Hoppes; this was seconded by Pat Dobbie. All were in favor; the meeting adjourned.
